The 2018 Ashland Farmers Market will be held on Saturdays, June 9 – October 6, 9:00 AM – 1:00 PM at 125 Front Street in the center of Ashland.

We welcome applications for participation in the AFM from any Vendor whose products and practices are consistent with the AFM mission and 2018 Rules of Operation. Please follow the directions below in submitting your application package.

Food Vendor application review and selection for the 2018 season will begin on March 1. To apply to become a Vendor for the 2018 season, please read the AFM 2018 Rules of Operation, then download and complete this form, and submit the following documents:

- a completed AFM 2018 Food Vendor Application; be sure to sign
- a copy of your insurance certificate indicating general liability insurance (in amounts not less than \$1,000,000 per person per incident and \$1,000,000 aggregate), and product liability insurance (in an amount not less than \$1,000,000) and making the Ashland Farmers Market the Certificate Holder
- your payment per tent for seasonal, alternate-week, or per-diem participation (\$195 for seasonal; \$100 for alternate-week or half-season; \$25 per market day for per-diem); please make all payments by check or money order, payable to the Ashland Farmers Market; your check will be cashed once you are accepted as a 2018 AFM Vendor

Contact the Ashland Board of Health directly to apply for a permit. Do not pay the permit fee until accepted by AFM.
